- 4. Treasurer's Report. David Duvall presented the report. Whitewater Quarterly Meeting's current balance was \$618.54. Since the beginning of 2022, the Quarterly Meeting had received \$150 in contributions, and no expenses had been paid out. David reminded Friends that contributions should be designated as contributions to North Meadow Circle of Friends with an annotation that they are contributions to Whitewater Quarterly Meeting. Friends were reminded that the usual expected annual contribution per meeting is \$50.00. Friends accepted the report.
- 5. Report on Levi Coffin Days event. Jane Stowe reported that together with Susan Lee Barton and Alan Patterson, she had attended the Levi Coffin Days event in Fountain City, IN, in Ninth Month. These Friends found only one vendor offering Confederate States of American battle flags or sale, and this vendor immediately pulled the flag from his display as soon as the inappropriateness of the flag at this event was explained to him. Whitewater Quarterly Meeting Friends minute their appreciation to Jane, Susan Lee, and Alan for undertaking this work on our behalf. A full written report is appended to these minutes.

## Report on Levi Coffin Days celebration September, 2022

Alan Patterson, Jane Telfair Stowe, and Susan Lee Barton all went to Fountain City Saturday morning to see whether any confederate flags would show up. Alan moved back to Richmond after several years in parts of Asia. He is fluent in Mandarin Chinese and was happy to hear a couple speaking Chinese at a booth when we arrived. He stopped to chat with them while Jane and I surveyed their wares. They had a variety of hats including several pro-Trump in '24 hats and "Trump Won 2020" flags. We saw more of those as we wandered around, but did not see any confederate flags. The couple Alan spoke with drove down from Michigan for the weekend to make some money.

We went down past the official vendor area to individual displays. The Lions Club organizers had told us that they have no control over what is in that area, and that the local Marathon gas station sometimes allows people to set up displays. We did not see any confederate flags in that area either. We saw some other questionable signs and banners that were not in what we think of as the spirit of the Coffins' work, but were not overtly racist.

We watched the local parade, and Jane noted that amidst many campaign signs, neither the Republican Party float nor the Republican Party information booth had any Trump signs.

As we retraced our steps to leave, we came upon the Chinese couple's booth from a different angle and noticed that the back was lined with a variety of flags for sale. Among them was an anti-Biden flag with the f--- word, a mock-up of the USA flag with the "stripes" all varieties of automatic weapons, and a confederate flag. (Photos attached.) Alan asked the vendor if he knew that the confederate flags were not allowed. The vendor said he had not known, thanked us for telling him, and immediately took down the flag. Our assumption was that he did not know the meaning of the flag and had simply brought items he was told would sell in this area.

We reported the flag to the information booth (including the fact that the vendor had put it away), but someone from a different organization was filling in for the Lions Club people at that moment. He said he would pass along our message, but did not give us the impression that he really cared.

Susan Lee and Richard Mitchell drove through Fountain City the next day on an OVYM visit, and stopped to make sure the flag had not returned. It had not.

## Recommendations:

- 1. Whitewater Quarterly Meeting could write to the Lions Club to let them know that contrary to their written policy, for the second year in a row a vendor was displaying and offering a confederate flag for sale. We would like to be of service to the Lions Club in helping to ensure that this does not happen again next year. We would like the Lions Club to require vendors to state in writing that they will not display or sell confederate flags for the Levi Coffin Days. Now that we have more advance time, we could offer to help contact potential vendors to obtain their promise, and ask how else we could help the Lions Club with this.
- 2. Since we saw at least two booths owned by people who knew little or no English and spoke Chinese, we suggest having the rules for vendors translated into Mandarin Chinese, to make sure that the rules are understood by all vendors. (Perhaps we could suggest some possible translators?)
- 3. We could ask the Lions Club to make sure that everyone staffing their event information booth be made aware of this concern and immediately report any infractions when they learn of them.
- 4. We would like to run all action ideas past the Richmond NAACP for advice and input.
- 5. We advise Friends to heed the previous advice of some Richmond NAACP leaders in not drawing unnecessary attention to the confederate flag if we can avoid its display in other ways. We don't need to make this a media event and battle if we can eliminate the threat in other ways. Since we believe the motivation for displaying the flag was to make money rather than to make a political statement or threat, we believe that working to make the vendor rules more clear could prevent such a mistake in the future.
