Ad hoc Restructure Committee Report to OVYM Executive Committee

In two meetings, we have focused on the role and functions of Quarterly Meetings in OVYM. We don't believe that it is helpful to try and work out "how" a new structure would look and function until we have unity on "what" that structure is to accomplish.

What

- 1. The business functions currently assigned to the QMs could be better carried out by the Executive Committee, the Yearly Meeting in session, or other OVYM committees.
- 2. Emphasis should be on mutual support of the monthly meetings and for linking their members. This is one of the QMs' historical functions, but not one that the current structure does well.
- 3. What is needed is spaces for worship, spiritual revitalization, creating connections between our meetings and person-to-person interactions.

How

Several gatherings each year might best meet our needs. These would:

- 1. Be organized by the yearly meeting and hosted by geographically-diverse monthly meetings.
- 2. Each with its own "theme." These might, for example, be organized by an OVYM committee the Earthcare Committee or Religious Nurture & Education or a wider Quaker organization such as FGC or AFSC whatever serves our needs.
- 3. Create a spiritual space to which people would be delighted to come spaces in which they would expect to be transformed.
- 4. Pay particular attention to the needs of children and their parents.

It is essential that we not lay down the current QMs until a new structure is in place. We hope to redirect the energy currently invested in QMs and use it .
